- Full papers are not required prior to the conference, although it would be useful for participants if they are made available. All accepted papers will be uploaded on the conference website prior to the conference.
- Full paper should be submitted by **July 31, 2021** to [religionruleoflaw@gmail.com](mailto:religionruleoflaw@gmail.com).
- Bilingual publication (Vietnamese and English papers) will be published on the conference website and printed into a manual as conference proceedings book, after peer reviewed by VNU-LS, with agreement from authors. The conference proceedings book will be published for non-commercial purposes. To facilitate the Vietnamese translating and editing process, we would appreciate it if you could adhere to the submission deadline and follow the specifications below in preparing your conference paper. Failure to comply will result in the paper not being included at the conference and the book.
  - First/cover page: Paper title, author's name and job/academic title, affiliation, residing city and country, and email address.
  - Font: Times New Roman, size 12
  - Single line spacing of text throughout
  - Microsoft Word Document Format (.doc or .docx)
  - Length: 3000 - 5,500 words, inclusive of footnotes
  - Language: English (papers of Vietnamese authors must be written in both Vietnamese and English).
