RELIGION, NATIONALISM, AND PEACE

This course will sample the literature on nationalism and ethnicity as it bears on conflict, with special focus on the role of religion. Some attention will be devoted to the place of religion in the formation of the idea of nationalism. Recent data on trends regarding ethnoreligious conflict will be examined and assessed. Specific cases will be examined, such as Bosnia, Sudan, Sri Lanka, and Israel/Palestine, with passing reference to other cases such as Iraq, Northern Ireland, and Kosovo. Attention will be paid to the ingredients of peace in such situations, including the accommodation of the rights of religious and ethnic freedom and equality, as well as how religious actors may function as peacebuilders.
